

United HealthCare Group Medicare Advantage PPO Plan Offering for Archdiocese of St. Louis Employees – Active and Retired

Effective January 1, 2023, the Archdiocese has partnered with UnitedHealthcare to offer eligible retirees the UnitedHealthcare® Group Medicare Advantage (PPO) plan as an option for your health care and prescription drug coverage. This plan is a custom Medicare Advantage (PPO) plan designed exclusively for Archdiocese of St. Louis retirees. The offering is different and should not be confused with individual UnitedHealthcare Medicare Advantage (PPO) plans that might be available in your area.

Important eligibility information:

- You must be retired from the Archdiocese of St. Louis and/or a dependent of a retiree.
- An individual working under 1,000 hours in a non-benefit eligible status, and maintaining that status throughout the duration of their employment, may also qualify as a retiree, if all other eligibility requirements are met.
- You must be entitled to Medicare Part A **and enrolled** in Medicare Part B.
- You **must continue paying your Medicare Part B premium** to be eligible for coverage under the **UnitedHealthcare Group Medicare Advantage (PPO) plan**.

How this plan offering affects you:

- Archdiocese of St. Louis endorses this plan. UnitedHealthcare will bill you directly for your monthly insurance premiums.
- When you become eligible to enroll in this plan, you will call UnitedHealthcare at **877-714-0178, TTY 711, 8 a.m. – 8 p.m. local time, 7 days a week**.

The **UnitedHealthcare Group Medicare Advantage (PPO) plan** is a Medicare Advantage plan that delivers all the benefits of Original Medicare (Parts A and B), includes prescription drug coverage (Part D), and offers additional benefits and features. This plan is not a supplement plan and does not pay secondary to Medicare. All claims are submitted directly to UnitedHealthcare for payment, not Medicare.
